## LETTER FROM THE EDITOR

"These are the times that try men's souls ...." As you may know, professional associations and societies have been experiencing reduced membership and dwindling workshop attendance. Certainly and unfortunately, the American Society of Clinical Hypnosis (ASCH) and the Greater Philadelphia Society of Clinical Hypnosis (GPSCH) have experienced this trend. The viability and future of GPSCH are now seriously in question. The GPSCH HypNews, now in its 16<sup>th</sup> year, is for the first time published and distributed in electronic form only, no original paper copy, as a cost containment measure. While printing and mailing via USPS represented a modest cost to the Society, it has been deemed a necessary adjustment to the current financial climate.

Founded in 1959, the Greater Philadelphia Society of Clinical Hypnosis has been one of the largest and most active ASCH Component Section. We have been most fortunate to have enjoyed the benefit of having as colleagues, friends and fellow GPSCH members stellar clinical hypnosis teachers, clinicians, researchers, scholars and human beings. I have been a GPSCH Member since 1992 and a member of the Board of Governors since 2000 serving as Secretary; Vice President; and President; and continuing to serve as Founding Editor, GPSCH HypNews; Member, Program Committee; and Chair, Bylaws Committee. I am certainly fully invested and committed to this Society's continuing to fulfill its mission of providing hypnosis education and training to the professional healthcare community.

During the past 60 years, the GPSCH Program Committee has organized twohour, half-day, all-day, two-day workshops and 20-hour ASCH Certified Training Programs offering APA and ASCH CEs covering a vast array of leading edge topics presented by national and international luminaries. In a pilot program with ASCH, we offered an all-day workshop offering CMEs as a reflection of ASCH's high regard for GPSCH. Workshop participants' post-workshop evaluations always report high scores and glowing comments of gratitude. However, the financial cost of maintaining a full academic

calendar of high quality workshops with presenters from near and far in the context of diminished revenue from decreasing membership and workshop attendance threatens GPSCH's survival.

The GPSCH Board of Governors has implemented a number of cost containment initiatives in an effort to extend the Society's life expectancy. However, the Board can only do so much with extremely limited financial resources. It is up to the constituency, You, GPSCH Members, to demonstrate your abiding interest, dedication and participation in our Society. One half of current GPSCH Members possess ASCH Certification/Approved Consultant status. If there is no GPSCH, then where will you obtain ASCH CEs to maintain your certification? North Jersey? New York? ASCH Regional Workshops in Virginia or other places requiring participants' travel and lodging costs?

GPSCH is now a patient in the intensive care unit. You, GPSCH Members, are the healthcare professionals in the position to ameliorate its condition.

Our next half-day workshop in April features an intriguing topic and speaker. If you are interested in supporting ongoing operation of GPSCH, register to participate in this workshop and benefit from a half-day of high quality continuing professional education offering APA and ASCH CEs. And Tell Colleagues. Encourage them to Register for this Workshop and Apply for GPSCH Membership. Applicants who are approved for membership will receive member rates for workshop attendance and we will have gained another congenial colleague.

Following the calculation of financial performance of the April workshop, the Board of Governors will assess how the Society may reasonably proceed, or not. As previously stated, I am fully invested and committed to the continued life and mission of GPSCH. To that end, I am prepared to financially underwrite some GPSCH budgetary items.

Perhaps you may wish to contribute to supporting our Society. While charitable donations to GPSCH are not tax deductible, you may wish to pay two years' Membership Dues this May with the understanding that the continued on page 6 Society may function for 2020-2021 only. # FOR YOUR CONSIDERATION

## Go Faster Alone, Go Farther Together

Overheard were two middle-aged women from the old country talking about the relative merits and challenges of marriage, single life and widowhood as they relate to morbidity, mortality and quality of life. While the thickaccented women were difficult to understand at times, certain statements made by them were quite clear.

Some discussion that was discernable included: "Fifty percent of men 65 years old live to be 87 and 25% live to be 93 years old. Fifty percent of women 65 years old live to be 90 and 25% live to be 96 years old. Fifty percent of couples 65 years old (at least one surviving individual) live to be 94 and 25% live to be 98 years old." So, it would appear that being in a couple relationship has positive influence on life expectancy.

"Becoming widowed is associated with a 48% increase in risk of mortality. Approximately one third of the increase can be attributed to selection, in that those who become widows are socioeconomically disadvantaged. Widowhood mortality risk increases for men if their wives' deaths were unexpected rather than expected; for women, the extent to which their husbands' death was expected matters less."

Multiple long-term studies have provided "compelling data showing that "relationship" is the single best indicator of physical health, emotional health and mortality." In their discussion of the salutary effects of being in a relationship, one of the women extolling the virtues of having her husband alive and living together with him said, "It's nice to have a man around the house - It makes a vas deferens!" *Cheers. -SGG*
